<u>Sub:</u> Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations')

With reference to the captioned subject, we would like to inform you that the Company had received a Show Cause Notice (SCN) from the Geology and Minerals Department, Porbandar, Gujarat, imposing a penalty of Rs 3,36,927/- along with an environmental compensation charge of Rs 70,755/- for discrepancies found between book value and physical stock, during their inspection of approved stock registration areas, as per their Calculation.

In response to the above SCN, the Company provided the clarification citing various contributing factors for the discrepancy. Nevertheless, it was subsequently decided to proceed with the payment as specified in the SCN. Accordingly, the Company paid the aforementioned penalty and environmental compensation charges on April 11, 2025. The matter stands settled as on date.

The information as required under Clause 20 of Para A of Part A of Schedule III of the SEBI Listing Regulations is enclosed in the 'Annexure A' below.
